

FRONT LIFT

1ST STEP REMOVE THE FRONT RACK. THIS IS TO GAIN ACCESS TO THE TOP BALL JOINT OF THE STRUT. REMOVE THE CLIP, THEN REMOVE THE LARGE RETAING NUT. APPLY LOCK TIGHT TO LARGE NUT WHEN REINSTALLING...

2ND STEP REMOVE THE TWO LARGE BOLTS ON THE STEERING KNUCKLE. THEN REMOVE THE STRUT FOR THE ATV.

3RD STEP REMOVE THE SPRING FROM THE STRUT, (USE A SPRING COMPRESSOR TOOL). THEN REMOVE THE BALL JOINT USE A PAIR OF GRIPS ON THE SHAFT IT SHOULD UNSCREW.



ALL THE LOCATIONS OF THE PARTS TO INSTALL FOR THE LIFT KITPAGE 2 OF 3 INSTALLATIONS ARE DESCRIBED AS IF YOU WERE **SITTING** ON THE ATV.



4TH STEP PLACE THE SPACER ON THE BALL JOINT ONTOP OF THE WASHER. MUST USE LOCKTIGHT ON THE THREADS OF THE BALL JOINT WHEN REINSTALLING ONTO THE SHAFT. THIGHTEN THIS JOINT TO FACTORY SPECS.


LAST STEP PLACE THE ALUM. SPACER UNDER THE SPRING. THEN ASSEMBLE THE STRUT IN REVERSE ORDER. REINSTALL THE STRUT ONTO THE ATV IN REVERSE ORDER ALSO. REPLACE ALL PARTS THAT WERE REMOVED IN THE PROCESS.



WHEN INSTALLING PLATES AND BRACKETS LEAVE ALL FASTENERS LOOSE UNTIL ALL HARDWARE IS IN PLACE THEN PROCEED TO SECURE THE KIT. AFTER INSTALLATION MAY HAVE TO ADJUST THE TIE RODS TO CORRECT THE ALIGNMENT OF THE WHEELS. IF BOOT GUARDS ARE INSTALLED MUST CHECK FOR PROPER CLEARANCE FOR THE RIMS AND BRAKE CALIPERS. TO CHECK FOR THIS LIFT THE FRONT OF THE ATV OFF THE GROUND AND TURN WHEELS FROM LEFT TO RIGHT AND MAKE SURE NOTHING IS TOUCHING THE GUARDS. MAY HAVE TO TRIM MATERIAL AWAY FROM THE GUARDS TO ACHIEVE THE CLEARANCE NEEDED.
