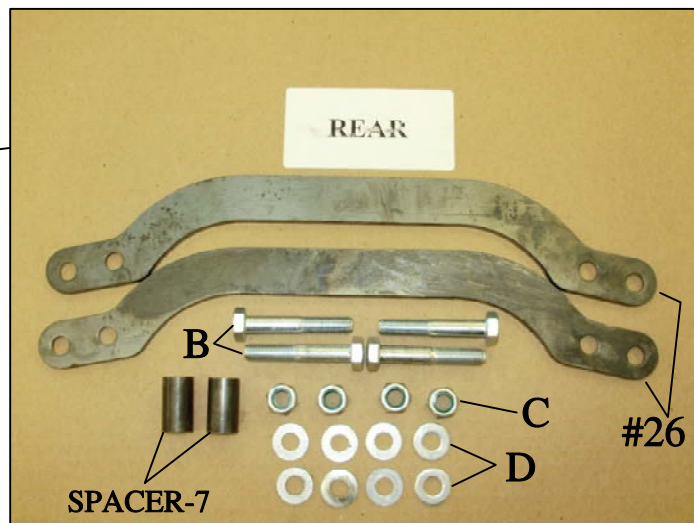
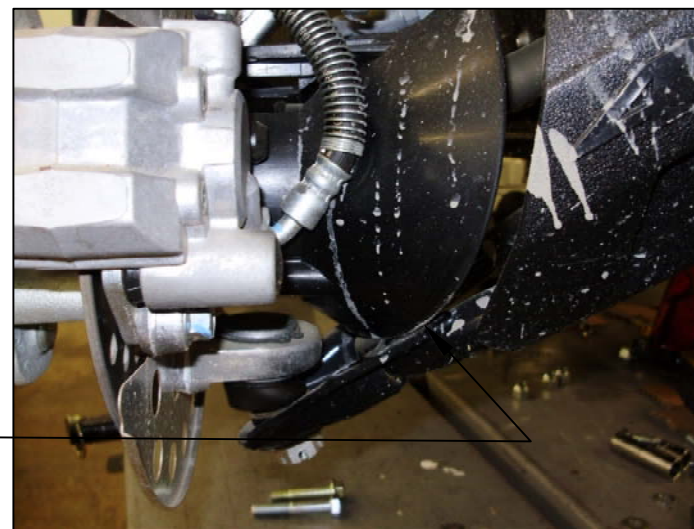
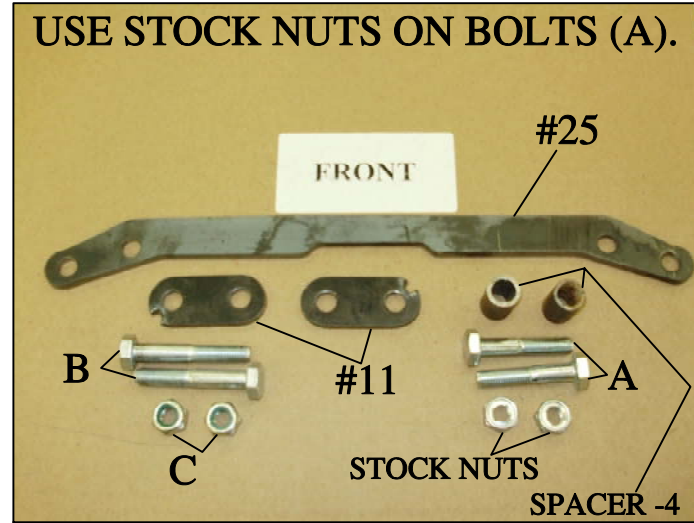
VERY IMPORTANT: ON SOME OF THE YEARS THE STOCK PLASTIC GUARDS WILL HIT THE ARMS ONCE LIFTED. MUST TRIM THE GUARDS FOR THE PROPER CLEARANCE NEEDED TO TURN THE HANDLEBARS FROM LEFT TO RIGHT. TRIM THE FRONT AND REAR OF THE GUARDS FOR CLEARANCE NEEDED.

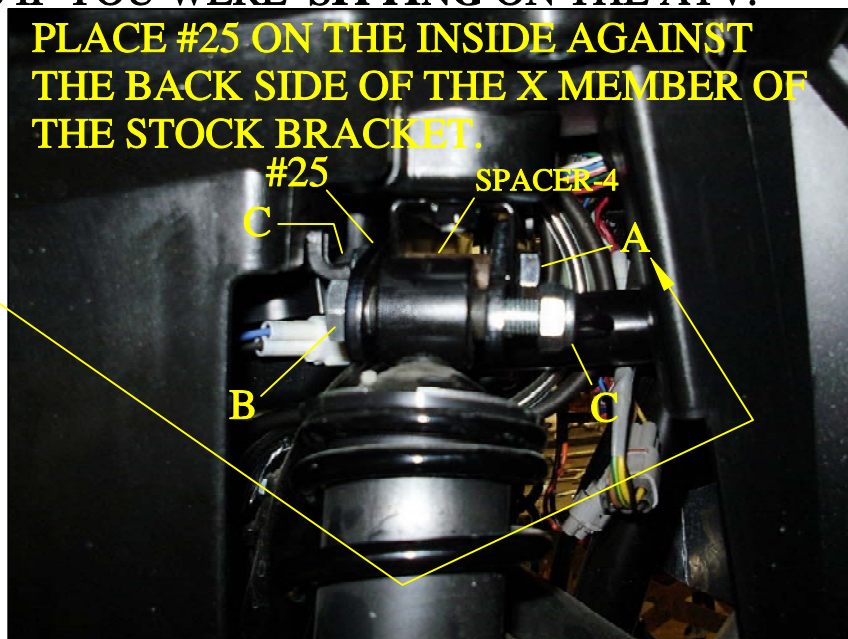


ALL THE LOCATIONS OF THE PARTS TO INSTALL FOR THE LIFT KIT INSTALLATIONS ARE DESCRIBED AS IF YOU WERE SITTING ON THE ATV.

BECAUSE THIS BOLT HAS TO BE SHORTER TO INSERT INTO THE MOUNT. IT IS RECOMMENDED TO USE A LOCK TIGHT AGENT ON THE TREADS WHEN INSTALLING THE LOCK NUT.

PICTURE OF THE LEFT SIDE FRONT MOUNT. REPEAT THE SAME PROCEDURE FOR THE OPPOSITE SIDE.

PLACE #25 ON THE INSIDE AGAINST THE BACK SIDE OF THE X MEMBER OF THE STOCK BRACKET.

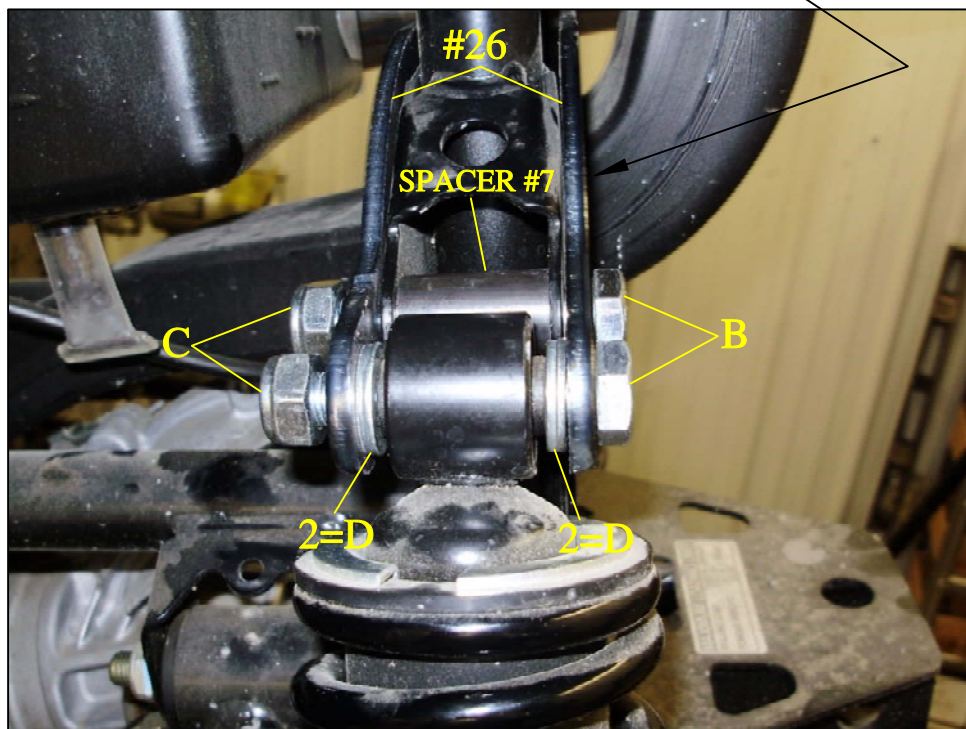


WHEN INSTALLING PLATES AND BRACKETS LEAVE ALL FASTENERS LOOSE UNTIL ALL HARDWARE IS IN PLACE THEN PROCEED TO SECURE THE KIT. AFTER INSTALLATION MAY HAVE TO ADJUST THE TIE RODS TO CORRECT THE ALIGNMENT OF THE WHEELS. IF BOOT GUARDS ARE INSTALLED MUST CHECK FOR PROPER CLEARANCE FOR THE RIMS AND BRAKE CALIPERS. TO CHECK FOR THIS LIFT THE FRONT OF THE ATV OFF THE GROUND AND TURN WHEELS FROM LEFT TO RIGHT AND MAKE SURE NOTHING IS TOUCHING THE GUARDS. MAY HAVE TO TRIM MATERIAL AWAY FROM THE GUARDS TO ACHIEVE THE CLEARANCE NEEDED.

ON SOME OF THE NEWER POWER STEERING MODELS THERE WILL BE A POWER STEERING MODULE HERE. SIMPLY REMOVE THE BOTTOM BOLT SLIDE THE BRACKET BEHIND THE PLASTIC GUARD AND REINSTALL THE BOLT THROUGH THE BRACKET. THIS IS ONLY ON THE POWER STEERING MODELS.
